### VII. Principal's Report -

Allie Heckard, Guidance Counselor – Informed the board of how her first year has been going as the VH Guidance Counselor. She reported that she has been busy with social emotion work, college visits, working with juniors and seniors in how to go after scholarships early on and getting to know the students and what their needs may be.

Bryan Feezor walked us all to the gym to look at the new climbing wall that just went up. The funding came from Widow Island Fund.

# VIII. Superintendent Report -

All articles were passed at the May 16<sup>th</sup>, 2023 district budget meeting that is held in the auditorium.

Again, wanted the board to know that the all doors are locked during the day. There are times in the day that there are a lot of traffic coming and going and the doors are unlocked for those times. Example would be before and after school.

Music concert Tuesday, May 23, 2023.

Curriculum – work still continues on aligning. The #1 focus this year and next is and will be literacy. Teachers are working on having all students ready to go when they get back next fall to begin Title I, literacy groups etc. The hope is to have them ready rather than work on where kids will be and then get them into the programs a few weeks into September.

Asked the board to watch for LD974 the draft planning overview which they are planning for the fall of 2024. This would put all Ed Techs on a much larger pay scale, 200% of minimum wage. The trickle affect could be financially hard on school budgets and the salaries of all staff.

Presented a slide show – Teacher appreciation week, Bryan Feezor delivered all types of coffee, soda, snacks, lunch, ice cream to the teachers on the day they had requested. He also popped popcorn each day for the staff in the teacher's room. There was a presentation on basic building blocks which is building students from K-grade 12 to be where they should be when leaving VH school to enter into the workforce or college. Monte thanked the board for helping out with treats for the staff on May 11<sup>th</sup>, 2023. That day was chosen as the "Big Surprise" as it was officially the day that they ended the Covid pandemic. Monte did update the board with how we advertise when positions open up at school. The position will start with the school community, then local advertising and lastly out nationally.
