- VII. Principal's Report
 - A. Robbie Brooker Library up-date Robbie Brooker along with the board did a walking tour of the library. He talked about some of the changes he is making with shelfing books and his plan on getting books inventoried. There are many books that have not been returned and he discussed his plan on how to help parents/students get them back on the shelves.
 - B. Senior Privileges The school board met with the seniors again and went over the privileges they felt were in their parameter of approving. The board again told the seniors how happy they were that they took the initiative to bring their thoughts/ideas to them. These privileges will be for the 23-24 school year only.
 - First in lunch line be respectful (All in favor)
 - Parking spot school will create a designated parking spot with a senior nameplate to mark the spot (All in favor)
 - Students in good standing, after obtaining a signed parent permission form may leave school during their study hall period. After checking on liability, the board felt that ride sharing would be fine with a parent permission slip. (All favor)
 - No open lunch/advisory. Special lunch events for all seniors (1-3)
 - Pending: High grade = no final (0-4) board felt teachers/administration decision
 - Pending: Exempt from final week of class before graduation (0-4) board felt teacher/administration decision
 - Graduation, June 15th, this date will not be moved and the board did not approve the week before off for the seniors. (0-4)

With these privileges, the seniors designed a "three strike" rule for each student who wants to maintain senior privileges. Those who are not following expectations regarding senior privileges will be informed of a strike from Mr. Selby, Principal or Mr. Feezor, Assistant Principal. Three strikes will end privileges for that student.

VIII. Superintendent Report – Monte reported to the board how Widow Island Fund is working this year. There are trips that have been planned for each grade level in the school. From traveling to museums with the younger grades to the mainland, to high school legacy trips. This year the 9th-10th graders will be traveling to Boston from November 6-9th and grades 11-12 will be traveling to Washington DC on those same dates. The idea is to have each student by the time they graduate to have the opportunity to visit museums, a park in Maine, visit another state, ride on a subway, travel on a plane. There are still smaller grants coming in such as Culinary Club, a request to help support a bit with the French Club trip in the spring, a solar eclipse trip in the spring to Moosehead lake to view a total eclipse at a prime location, ski trips for elementary and middle school, Lego Robotics supplies and college trips.
